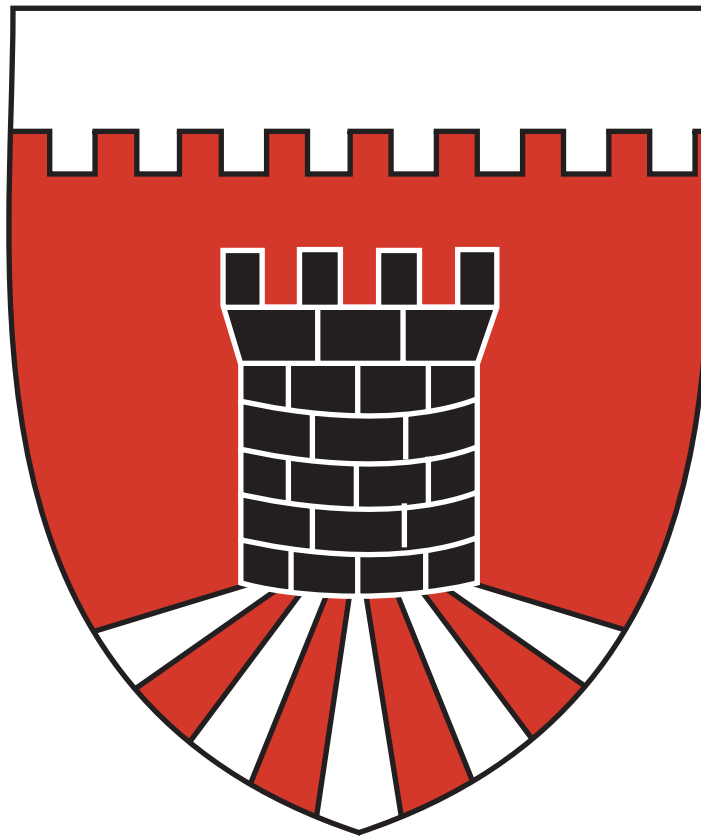

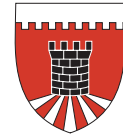

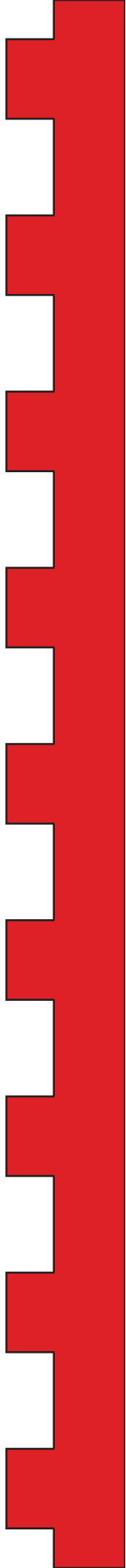
To the BOD of Dragonspine,

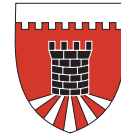
We had almost 100 entries for Qualifications and there were some very well done entries. For the first time every office will be contested. Competition inspires more effort to be the best you can.

Greetings from the Duchy of Crimson Wood!

We would like to take this time to thank the Kingdom of Dragonspine and Principality of Westmarch for their continued support to our chapter over the last year.

During the last year our chapter has had some activities that I would specifically like to highlight. First is that we were granted Duchy status by the Kingdom of Dragonspine. Second is that Crimson Wood hosted Feast of Mars III in September 2007, which has been the second most successful reoccurring event in Northern California. Third we had a successful camp out in September of last year. In May 2008 we lost our Regent to work commitments. In June we elected William of Wolfscarin to replace Sirrah Elspeth as our Regent.

We have also been active in recruiting. We had some of our members participate in the Amtgard Demo at DunDraCon in February of this year. This did not gain any new members for Crimson Wood, but did help other areas of Westmarch. We had a table at SebastaCon in March 2008, which has gained us one new member.

In May 2008 we participated in a Middle School Renaissance Fair in Sebastopol. The first week we instructed the students how to make four in one chain mail. The second week had different schools and we did the same chain mail workshop along with a fighting demo. The organizer of the Renaissance fair informed us that the chain mail workshop was one of the most popular stations. Many of the students created thank you cards that were sent to us. Scans of these thank you cards start on page 51. Our participation in this event gained us 8 new members the following week.

In addition to our direct recruiting efforts we encourage our members to recruit friends. To help provide incentive we give 2 extra credits to any member who recruits new members that show up at least 4 times. This must be done outside of normal recruiting events, but it does help us get new members. All of our recruiting efforts have resulted in 25 new members sign waivers between May 31st and July 24th.

Crimson Wood is a stable Duchy that pulls between 15 and 35 members most weeks during the last year. Our monthly population base has ranged between 37 and 55 during the last year. This is without counting the visitors from other lands that show up from time to time. During the winter we had some reduction in numbers and had to even cancel one week due to the heavy rain. We continue to have a large portion of our members show up once or twice a month. In an effort to align our schedule with the rest of Westmarch our current reign is being extended until September 27th.
